# Tokyo-London Green Finance Seminar 2021 and Call for Participants

Based on the Memorandum of Understanding between the Tokyo Metropolitan Government (TMG) and the City of London Corporation concerning the exchange and cooperation, which was concluded in December 2017 (\*), the Green Finance Seminar is to be organized jointly by TMG and the British Embassy in Japan.
