Following the signing December 2017 of the *Memorandum of Understanding Between The City of London Corporation and Tokyo Metropolitan Government*, both cities are working together to grow as international financial centers. They are also promoting high-level discussions and co-hosting events. This seminar is part of these collaborative efforts.

The upcoming 9th seminar will focus on fintech and AI applications as well as asset management to increase financial services trade between Japanese and UK firms, highlighting new opportunities for collaboration in these sectors. 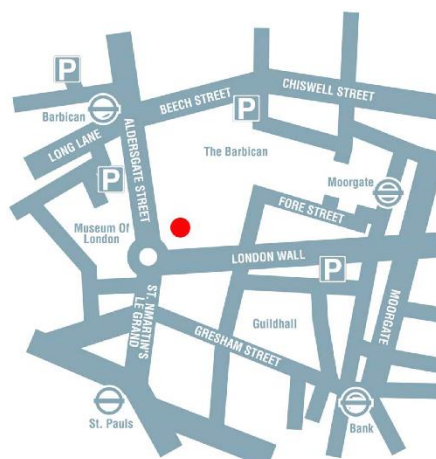
